With over 25 years of clinical experience, Dr. Grewal has a great reputation among the legal community for helping personal injury patients.

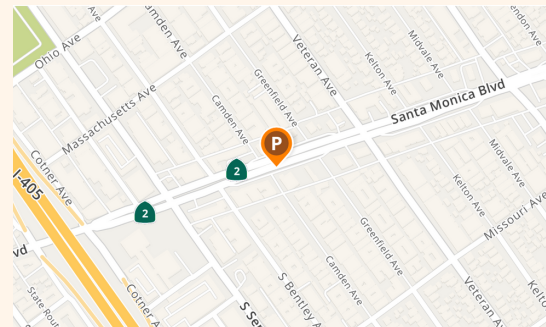
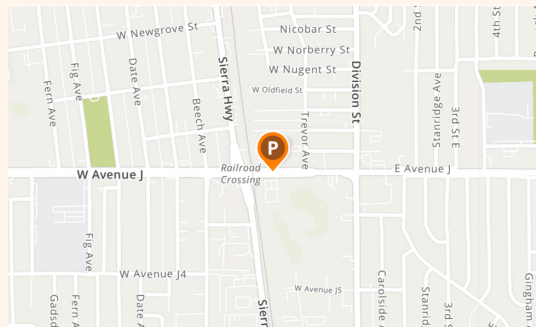
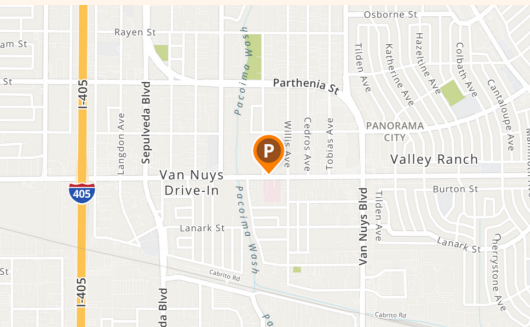
